Information Collected

Davidbarnett.org automatically collects and tracks various information, including but not limited to, (1) the home server domain names, e-mail addresses, type of client computer, and type of web browser of visitors to davidbarnett.org web site.; (2) the e-mail addresses of visitors that communicate with davidbarnett.org via e-mail; (3) Personal Information specifically provided by you in online forms, registration forms, surveys, and contests entries; and (4) user-specific information on what pages visitors access.

Cookies
